Civil Jury/Court Backlog Factor = number of cases pending over 1 year divided by average number of cases added in 6 months.

Civil Appeals Backlog Factor = number of cases pending over 60 days divided by average number of cases added in 30 days.

Small Claims Backlog Factor = number of cases pending over 90 days divided by average number of cases added in 30 days.

Felony Backlog Factor = number of cases pending over 90 days divided by average number of cases added in 45 days.

Misdemeanor Backlog Factor = number of cases pending over 60 days divided by average number of cases added in 30 days.

Civil Suspension Backlog Factor = number of cases pending over 30 days divided by average number of cases added in 30 days.

Annulment, Desertion, Divorce, Other & Separation Backlog Factor = number of cases pending over 9 months divided by average number of cases added in 4.5 months.

Parentage Backlog Factor = number of cases pending over 1 year divided by average number of cases added in 6 months.

Magistrate Child Support - Divorce Backlog Factor = number of cases pending over 60 days divided by average number of cases added in 30 days.

Magistrate Child Support - Parentage Backlog Factor = number of cases pending over 1 year divided by average number of cases added in 90 days.
