## Form 600-00051: Permanent Registration for Media Organization/Individual

Prior to submitting any application, read the <u>superior court rule</u> and <u>Supreme Court rule</u> regarding devices and the accompanying <u>administrative order</u>.

Submit application as indicated in the instructions.

- 1. This form allows media organizations and individuals to obtain a permanent registration certificate. See V.R.C.P. 79.2(d)(2)(A); V.R.A.P. 35(d)(2)(A); A.O. 46 § 1(b).
- 2. News organizations must file one form and name a primary registrant. The primary registrant must certify and sign the form. The organization must list other persons authorized under the registration.
- 3. An individual (not associated with one organization) must complete and sign the form.
- 4. The completed form must be saved as a PDF and sent to jud.mediaregistration@vermont.gov.
- 5. The applicant will receive written notice of a decision by email.
- 6. The applicant will receive a certificate by email if the application is granted.
- 7. An applicant can seek review of a denial by filing written notice with the Supreme Court.
- 8. Registered organizations and individuals are listed on the Judiciary website at www.vermontjudiciary.org/mediaregistration
- 9. All registrants (whether organizations or individuals) must update registration information, including the list of persons authorized to act under the registration.
