## I. PROMULGATED RULE AMENDMENT

Order Promulgating Amendment to A.O. 49

This Order was promulgated on March 18, 2020; effective immediately.

This order amends A.O. 49, which declared a Judicial Emergency on March 16, 2020, in response the COVID-19 pandemic.

Pursuant to the order, hearings for nonemergency matters, although generally suspended, may proceed if litigants participate remotely and are not in the courthouse in the discretion of the Superior Judge and the Court Administrator.

The Supreme Court in its discretion may hold oral arguments for summary or full-Court proceedings by telephone or consider cases without oral argument.

#### II. COURT ADMINISRATOR DIRECTIVE

PG-11 - Administrative Directive (Electronic Filing) Windham, Windsor & Orange Units

This directive was signed on March 19, 2020.

The directive indicates that pursuant to 2020 Vermont Rule for Electronic Filing 1(d), the Court Administrator is authorizing electronic filing to begin on April 20, 2020 in all divisions of Windham, Windsor, and Orange Units.

Efiling will be done through Tyler Technologies service Odyssey File & Serve. The File & Serve website is available at <a href="https://vermont.tylerhost.net/ofsweb">https://vermont.tylerhost.net/ofsweb</a>. There is a self-help section that provides information for electronic filers. c. Obligation under A.O. 41

Attorneys are reminded that an "attorney must report to the State Court Administrator within thirty days any change of the office mailing or electronic mail address" and that "[n]otice sent to a reported address is sufficient even if not received by the attorney because of failure to report the proper address or failure of delivery not caused by the court." A.O. 41, § 4(c); see A.O. 44, § 1.

### d. eCabinet Registration

Administrative Order No. 44 requires attorneys in active status to register up to three email addresses in eCabinet for purposes of receiving notices of hearing and other documents. You may include staff email addresses in the three email addresses that you specify. eCabinet registration is required whether you practice in court or not.

If you have already registered in **eCabinet**, the email address(es) you provided as part of that process will be used.

If you have not already registered in **eCabinet**, please go to <a href="https://efiling.eservices.crt.state.vt.us/">https://efiling.eservices.crt.state.vt.us/</a>, click **Register Now**, and follow the simple prompts. Attorneys will need their attorney license numbers to register. You are also reminded that you are required to update the email address(es) and other contact information you have registered as soon as there are any changes, including changes to staff email addresses you may have included with your registration. Notification to <u>JUD.AttyLicensing@vermont.gov</u> or in **eCabinet** of a change to your contact information does not automatically notify the other. It is your responsibility to notify both. If you are a member of the Vermont Bar Association, you will also need to separately notify the VBA.
