**Limited Emergency Pro Bono Law License  
Request Form**

4. By signing and submitting this request form, I acknowledge that a Limited Emergency Pro Bono Law License only authorizes me to provide legal services directly related to the Flood Emergency. Those legal services must be provided pro bono, without compensation, expectation of compensation, or other direct pecuniary gain to me. Those legal services must be coordinated through an established not-for-profit bar association, pro bono program or legal services program, or through such organization(s) specifically designated by the Vermont Supreme Court.

By signing and submitting this request form, I acknowledge that I am subject to the Vermont Rules of Professional Conduct and the disciplinary jurisdiction of the Vermont Supreme Court when requesting a Limited Emergency Pro Bono Law License, as well as when practicing under a Limited Emergency Pro Bono Law License.
6. By signing and submitting this request form, I acknowledge that I am not authorized to represent a client in court, except:
  - a. If I have an inactive Vermont law license, I may represent a client in court after filing with my notice of an appearance an affidavit stating I am representing the client pursuant to a Limited Emergency Pro Bono Law License.
  - b. If I am an out-of-state lawyer with a Limited Emergency Pro Bono Law License, I may represent a client in court if I am admitted pro hac vice license pursuant to Section 16 of Administrative Order 41. I understand that the application fee will be waived.

If I use a Limited Emergency Pro Bono Law License to represent a client in court, I will be required to comply with all Vermont court rules, including the Vermont Rules for Electronic Filing.

7. By signing and submitting this request form, I acknowledge that the authority to practice law granted by a Limited Emergency Pro Bono Law License will terminate when the Vermont Supreme Court determines that the Flood Emergency has ended or abated to such an extent that relaxation of the Rules of Admission to the Bar of the Supreme Court and Supreme Court Order Administrative 41 is no longer required.
