Hi Denise,
I'm expecting this to cost \$1000 per month. I normally ask people to pay \$3000 up front. The payments are a flat fee for my time and there won't be any costs for expenses since the State will pay for them. There are currently two counties and two dockets. I will plan on working on both of them, but I may let the public defender's office in Caledonia start the case there and I will then figure out the logical step to either get it transferred to Windsor or to resolve it.

So, please feel free to let me know how you would like to proceed. If you can pay \$3000, then that would cover June, July, August and your next payment of \$1000 would be September 10, 2019. You would then pay \$1000 on the 10th of each month thereafter until the case resolves. However, I will also agree that once you have paid \$8000 (after the first 8 months - and if the case is still pending), then we can reduce the monthly fee to \$400 per month.
