STIPULATED MOTION TO CONTINUE REINSTATEMENT HEARING

NOW COMES William W. Cobb, the Respondent and Applicant for reinstatement, by and through counsel Brice C. Simon, Esq., of Breton & Simon, PLC, and Jon T. Alexander, Disciplinary Counsel, and hereby stipulate and jointly move to continue the reinstatement hearing currently scheduled for September 15, 2023. In support whereof, Respondent/Applicant and the Disciplinary Counsel submit the following:

1. Mr. Cobb would appreciate the opportunity, if this Motion is granted, to file a Motion to Amend Petition and proposed Amended Petition and Amended Affidavit in Support of the Amended Petition for reinstatement, addressing issues that were identified during the discovery process and which bear on Mr. Cobb's ability to meet his burden of proof at the hearing that he has been rehabilitated. It is contemplated that the Motion to Amend Petition and proposed Amended Petition will be filed no later than September 15, 2023, the original hearing date.
2. Additional time would allow Mr. Cobb to complete various tasks and address a number of issues that he will not have time to do before the September 15, 2023 hearing.
3. Mr. Cobb, by making this request for an extension of time, hereby agrees to waive and does waive all deadlines or timing requirements, and consents to a hearing after November 15, 2023 and a decision being rendered in whatever additional time frame is preferable to the Panel.
4. By signing below, Jon T. Alexander, Disciplinary Counsel for the Vermont Judiciary Professional Responsibility Program, supports Respondent's request herein.

5. There will be no prejudice caused by the requested extension. In addition, by submitting this Motion for Extension, Mr. Cobb acknowledges that he will remain suspended, and will not attempt to resume the practice of law in Vermont, until after the extended hearing date and then only upon an order reinstating his license to practice law in the State of Vermont.

WHEREFORE, Respondent / Applicant William W. Cobb hereby moves to continue the September 15, 2023 reinstatement hearing until on or after November 15, 2023, and consents to a decision being rendered in this matter in such additional time thereafter as the Board deems appropriate.
