Until the judgment due is paid in full, Defendant shall notify the Vermont Restitution Unit in writing of any change of home address or employment within 30 days of such change including the name, address and phone number of any new employer.
- 4. The Restitution Unit shall have the authority to Collect from an offender subject to a restitution judgment order all fees and direct costs, including reasonable attorney's fees, incurred by the Restitution Unit as a result of enforcing the order and investigating and locating the offender.

This Order is Entered into by Stipulation. The parties agree that the victim incurred the uninsured material loss noted above and that Defendant has the ability to pay noted above. The parties waive any further hearing regarding restitution understanding that both parties have a right to a hearing regarding the amount of restitution and the ability to pay restitution. Both parties knowingly and voluntarily waive their right to appear in person before the court.
