**CERTIFICATION IN SUPPORT OF COMPLIANCE WITH THE CARES ACT**

*Pursuant to Administrative Order 49, ¶ 22, all plaintiffs who file eviction actions on or after March 27, 2020, must file a certification in substantially this form, certifying either that they have complied with the CARES Act’s restrictions or that the CARES Act requirements do not apply. If an eviction was filed without this certification, plaintiffs must file it by August 14, 2020.*
