

Odyssey: Vermont Judiciary's Next Generation Case Management System

A Message from Patricia Gabel, State Court Administrator & Project Sponsor:

Dear Colleagues,

On June 5th, I was pleased to announce this exciting news to the Judiciary:

"I would like to extend congratulations to our Next Generation Case Management System project team and to the hardworking employees in the Judicial Bureau, Information Center, Finance, and the Division of Research and Information Services for their work over the past week (and weekend!) during the 'Go Live' event of the Next Generation Case Management System implementation in the Judicial Bureau.

This is a significant milestone for the Judiciary. As the first of five such deployments that will occur over the next 18 months, the Judicial Bureau go-live is the result of months of dedication and hard work by our Judiciary Project Team, supported by RIS, Trial Court Operations, Finance, Judicial Bureau Staff, and our partners at Tyler Technologies.

As you may know, this first roll-out is focused solely on replacing the Judicial Bureau (JB) functionality of our legacy systems with Odyssey, by Tyler Technologies. The significant efforts of our NG-CMS project and governance teams has resulted in a technology solution that is configured to support evolved business processes and increased efficiency and will ultimately result in easier interactions with the court."

Over the past month, the project team has given careful consideration to lessons learned from the Phase I Judicial Bureau go-live, as well as information from Tyler about a new version of the Odyssey software that contains important features for Trial Court Operations.

At the August 5th Steering Board meeting, the board will review options for how to proceed with the Phase II, first Regional Trial Court rollout (Windsor, Orange and Windham Counties). Phase II is currently planned to go-live near the end of the calendar year. That date could change, depending on the outcome of the Steering Board meeting. If the schedule changes, it will be because of the importance of ensuring that users receive sufficient training and of the need to work through the various changes in business processes that will likely occur.

It's very important that we get this first trial court implementation done as well as possible. Once the Steering Board makes a decision about the Phase II go-live date, that information will be shared throughout the Judiciary in the next newsletter.

Q: Once the trial courts move to an electronic case management system, will I be required to electronically file my case or can I still use paper?

A: Attorneys will generally be required to use the electronic filing system for all filings. Self-represented litigants may choose to continue to file paper documents by hand or mail, or may elect to register the electronic filing system.
