Economies-of-Scale at the Vermont Judiciary Trial Level August, 2009

Recognizing that the Chittenden courts handle by far the largest caseload in every type of jurisdiction, this study measures the "Chittenden equivalents," the number of courts comparably staffed, that would be required to handle the entire State on a regional basis, based on the Court Administrator's FY2008 annual "cases added" statistics.

No attempt is made to account for the factors that would be present in a "real" consolidation and absent in a "virtual" consolidation (travel costs, for example).

This study does not attempt to prioritize economies of scale with other goals of the judicial system (access to justice, for example).
