for the State of Vermont, upon his oath of office, charges:

LEWD AND LASCIVIOUS CONDUCT

CHARGE CODE: 13V2601

OFFENSE CLASS: F

On or about June 17, 2017, MELVIN FINK (DOB:03/31/1943) of Springfield, Vermont, at Peru, Vermont, was a person who knowingly and unlawfully engaged in open and gross lewdness and lascivious behavior, to wit; MELVIN FINK, without lawful purpose or consent, grabbed the back of [REDACTED] [REDACTED] s head, forced her face to his face, and inserted his tongue into her mouth and partially down her throat, in violation of 13 V.S.A. § 2601 and against the peace and dignity of the State of Vermont.

PENALTY: Imprisonment for not more than five years or a fine of not more than \$300.00 or both.


