SPECIAL DISCIPLINARY COUNSEL'S  
MOTION TO EXTEND THE NOVEMBER 22, 2021 DEADLINE

Navah C. Spero, Esq., Specially Assigned Disciplinary Counsel ("Special Disciplinary Counsel") in this matter, moves to extend the November 22, 2021 deadline to Reply to Respondent's Response to Motion for Sanctions to November 23, 2021. In support, Special Disciplinary Counsel states as follows:

1. Special Disciplinary Counsel had been out of the office from November 1 through November 15 to deal with a death in her family.
